ESSENTIAL DUTIES:

New Hanover County is accepting applications for full-time firefighter/apparatus operators, where selected applicants meeting the requirements for and successfully completing an assessment may be selected to fill current vacancies, or comprise an eligibility list which will be used to fill future vacancies. Duties include protecting life and property by responding to emergencies; securing the scene; extinguishing the fire; salvaging structures and their contents; and providing basic emergency medical care as a first responder. Responds as the primary apparatus operator to reports of emergencies which includes fires, emergency medical requests, technical rescue incidents, hazardous materials response and other types of situations that may present hazards or harm to people or property. Other duties include performing maintenance of vehicles and fire stations, conducting pre-plan fire inspections, acting in the absence of the Company Officer on assigned shifts and representing Fire Services to the public at various events.

New Hanover County Fire Rescue is comprised of a team of dedicated emergency response professionals who work to protect and educate citizens from the threats of fire and other emergencies. Our employees stay committed to the County's model of good governance working 24 hours a day in eight (8) fire/rescue stations, protecting 220 square miles of the County. The department partners with Cape Fear Community College to sponsor internship students in the First Responder Academy and also offers a first class volunteer firefighter program. These programs provide opportunities for those wishing to volunteer their time or start their own career in the fire industry. Ideal candidates for this department combine the department's values of honor, dedication, compassion, service and excellence with the County's overarching shared values and vision of a vibrant, prosperous and diverse coastal community committed to building a sustainable future for generations to come.

MINIMUM QUALIFICATIONS:

HS diploma/GED and 4 years of related firefighting experience; or three years of related firefighting experience, including two years as a full-time firefighter with New Hanover County Fire Services.

- IFSAC or ProBoard accredited certification as Technical Rescue General; Vehicle Machinery Rescue; Ropes
- IFSAC or ProBoard accredited certification Driver Operator Pumps and Aerial certifications

Required as a condition of continued employment:

- NHC Fire Rescue Foundational Training – Levels 1 & 2 (within 1 year)
- IFSAC or ProBoard accredited certification as Fire & Life Safety Educator Level 1
- Obtain one (1) Technical Rescuer specialty (Water Rescue is preferred)

OTHER INFORMATION:

Hours: Rotating 24-hour shifts from 7AM-7AM, including weekends and holidays.

Applicants must be at least 21 years of age and live within 90 minutes of the county at time of appointment.

Candidates who submit an application prior to December 15th, and are referred over to the department should expect the first assessment to begin the first week of January 2018.

Candidate Assessments will be held on 1/11/18 or 1/12/18, 2/1/18, and 2/15/18 for all other applicants. This will create a eligibility pool to fill vacant positions for the upcoming year.

TRAINEES: Applicants meeting the minimum required education, but lacking certification requirements from the list below and/or lacking one of the required years of experience, may be considered at a trainee rate of \$12.46 per hour and if selected will remain at the trainee rate until the minimum experience requirement and/or all required certification requirements are met. All certification and minimum experience requirements must be met within one (1) year of employment.

- NC or National Registry EMT certification
- IFSAC or ProBoard accredited certification as Technical Rescue General;
- IFSAC or ProBoard accredited certification as Technical Rescue Vehicle Machinery Rescue;
- IFSAC or ProBoard accredited certification as Technical Rescue Ropes;
- IFSAC or ProBoard accredited certification as Driver Operator Pumps;
- IFSAC or ProBoard accredited certification as Driver Operator Aerial.

Employment references will be conducted on all applicants being considered for hire. Candidates with previous military experience should attach a copy of their DD-214 (long form) to this application. This will be accepted as one of your employment references.

After the closing date for this position applications will be screened by Human Resources. Applicants referred to the department will receive an e-mail with information concerning the Candidate Assessment Process.
